**PARKS & RECREATION BOARD MINUTES**  
**MARCH 10, 2014**  
***DRAFT - NOT APPROVED***

Present: Chairman Mike Fulca, Wade Middaugh, David Mars, and Vee Fasciotti.

Chairman Mike Fulca called the meeting to order at 6:10 p.m.

Chairman Mike Fulca called for any amendments or additions to the agenda dated 03-10-2014. With none, the agenda is approved.

Chairman Mike Fulca called for amendments or changes to the minutes dated 02-10-2014. With none, Chairman Mike Fulca called for a motion to approve the minutes as written. Vee Fasciotti made the motion. David Mars seconded the motion. Motion carried.

**NEW BUSINESS:**

1. ***Easter Egg Hunt*** - Vee Fasciotti spoke with the guests in attendance regarding their help with the easter egg hunt this year. The hunt will be held on April 12th at 1 p.m. at the City Park if weather permits. Vee Fasciotti stated that if it is raining or the ground is too wet, the hunt will be moved into one of the gyms at the school. Wade Middaugh stated that the city budget has \$300 set aside for this event.
2. ***Avenue of Flags*** - Wade Middaugh stated that the Board of Aldermen discussed the avenue at their last meeting and decided they would like a committee set up. The aldermen also requested that the Parks and Recreation Board oversee the creation of the committee and be a part of the process as the avenue is quasi park land. After discussion, Vee Fasciotti made a motion that the Parks and Recreation Board oversee the creation of an Avenue of Flags committee. Wade Middaugh seconded the motion, motion carried.

**OLD BUSINESS:**

1. ***2014 Ashland Fall Festival*** - Wade Middaugh stated that there are seven vendors so far with total money raised being \$255.00. David Mars asked Wade for a generic sponsorship letter.

2. ***Long Range Planning Discussion*** - The Board discussed the park system and the fitness trail project. Wade Middaugh stated the City has received pricing on the project and City administration is currently working on the budget. It will be presented at the board of aldermen meeting on March 18th.
