PARKS & RECREATION BOARD MINUTES

NOVEMBER 9, 2015

Chairman Mike Fulca called the meeting to order at 6:00 p.m. at 109 E. Broadway, Ashland, MO. Chairman Mike Fulca called for a motion to approve November 9, 2015 agenda. Board Member Charlotte Beuselinck made a motion to approve the agenda for November 9, 2015 and seconded by Board Member Mary Logsdon. Motion carried.

1. Trees in the Park
