**JULY 8, 2013**

Chairman Mike Fulca called the meeting to order at 6:05 p.m.

Chairman Mike Fulca called for any amendments or additions to the agenda dated 07-08-2013. With none, the agenda is approved.

1. Ashland Fall Festival
