

**PARKS & RECREATION BOARD MINUTES**  
**JUNE 14, 2010**

Acting Chairman Gary Sieckman called the meeting to order at 6:10 p.m.

**OLD BUSINESS:**

A. *City Park Inventory and Master Plan*

Wade Middaugh presented to the Board that this discussion was to be held with the presence of the City Administrator and Mayor. The Board decided to table the item until the July 2010 meeting and to invite the Community Development Director to the meeting as well.

B. *Ashland Ridge City Park Dedication—June 13, 2010*

After discussion, Gary Sieckman asked for a motion to approve August 21, 2010 as the new tentative date for the Ashland Ridge City Park Dedication. Wade Middaugh made the motion. C. *Outdoor Movie Events*

Wade Middaugh presented to the Board that the event scheduled for June 12, 2010 showing Cloudy with a Chance of Meatballs had to be rescheduled due

to the rain. It was rescheduled for June 19, 2010. Also, Wade presented the Board a list of 6 possible movies for the community to vote on in July to see at the Outdoor Movie Event scheduled for August 14, 2010. After discussion Jaws and The Blind Side were removed and Wade Middaugh said he would replace the two choices with other PG rated movies.

Wade Middaugh said he would pass this along to the department to look into.
