

**PARKS & RECREATION BOARD MINUTES**  
**AUGUST 9, 2010**

Present: Chairman Mike Fulca, Vee Fasciotti, Wade Middaugh, David Mars, Gary Sieckman, Jennifer Wyatt, and Garry Nichols.

Absent: Carrie Ward.

Guests: Jeff Ditzfeld.

Chairman Mike Fulca called the meeting to order at 6:00 p.m.

Roll call was taken and the following members were in attendance: Chairman Mike Fulca, Vee Fasciotti, Wade Middaugh, David Mars, Gary Sieckman, Jennifer Wyatt, and Garry Nichols.

Chairman Mike Fulca called for any amendments or additions to the agenda dated 08-09-2010. Wade Middaugh requested to amend the agenda to add Park Restroom Sealant to old business. With this amendment Chairman Mike Fulca called for a motion to approve the amended agenda. Jennifer Wyatt made the motion, Gary Sieckman seconded the motion. Motion carried.

Chairman Mike Fulca called for a motion to approve the minutes dated 07-12-2010. Gary Sieckman made a motion to approve the minutes for 07-12-2010. Vee Fasciotti seconded the motion. Motion carried.

**NEW BUSINESS:**

A. *Ashland Fall Festival*

Wade Middaugh presented an overview to the Board of plans for the 2010 Ashland Fall Festival.

**OLD BUSINESS:**

A. *Outdoor Movie Events*

Wade Middaugh informed the Board that voting for the Community Choice Movie on August 14, 2010 had ended. 392 votes were cast and Ghostbusters won with 127 votes. He reminded the Board that this is the last Outdoor Movie on the year.

B. *Ashland Ridge Park Dedication*

Wade Middaugh reported to the Board that the City Public Works Department has been working very hard at Ashland Ridge Park to finish the improvements for the tentative dedication date of August 21, 2010. He also reported that the improvements may not be complete by the tentative date and asked that the Board look at alternatives. After discussion, Vee Fasciotti made a motion that

if August 21, 2010 is not feasible to complete the improvements the dedication ceremony will be moved to September 18, 2010 at 1 p.m. Jennifer Wyatt seconded the motion. Motion carried.

*C. Park Restroom Sealant*

Wade Middaugh presented the Board with a letter from Charles Seznee, Community Development Director regarding a sealant used for the City Park Restroom walls to prevent the smells that have been occurring. This issue was discussed at the Parks and Recreation Board Meeting in July 2010. The letter addressed the estimated price of \$222 for paint removed and masonry waterproofing paint to seal the walls. After discussion Garry Nichols made a motion to send a recommendation to the Board of Aldermen for approval of the sealant. Gary Sieckman seconded the motion. Motion carried.

**DISCUSSION:**

- A. Wade Middaugh presented the Board with a letter from Brian D. Canaday with the Southern Boone Jaycee Youth Football Program. In the letter Mr. Canaday asked to use the open green space at the City Park Sunday afternoons September-October 2010 to paint and use 2 football fields. After discussion Garry Nichols made a motion to approve the request. Gary Sieckman seconded the motion. Motion carried.
- B. Wade Middaugh presented the Board with a letter from David A. Parkes with Ashland Christian Church. Mr. Parkes requested to use archery targets in the northeast niche of the park on September 26, 2010 for their church picnic. Wade Middaugh made a motion to approve the request. Jennifer Wyatt seconded the request. Motion carried.

**GUEST COMMENTS:**

- A. Jeff Ditzfeld of 600 Summertime Drive asked the Board for their thoughts and the history of any discussions regarding a skateboard park. Chairman Mike Fulca said that the issue has been discussed several times, but at this time there is not usable area for a park, nor available funding. The Board thanked Mr. Ditzfeld for taking the time to visit the meeting and asked that if he continues to see interest in a skateboard park to please return to a meeting with more information.

Chairman Mike Fulca called for a motion to adjourn the meeting. Vee Fasciotti made the motion, Gary Sieckman seconded. Meeting was adjourned at 6:46 p.m.
